#### The American Wartime Museum

The American Wartime Museum<sup>TM</sup> will be unlike any other museum in our country:

- We will tell the stories of veterans from all military branches as well as corresponding units of the Reserves and National Guard.

#### Wartime Oral History Project

The Wartime Oral History Project (WOHP) matches a staff of volunteers with war veterans to record their stories on film. The videos are provided to the veterans as well as retained at the American Wartime Museum and the Library of Congress. Select interviews are edited into concise videos and posted on our website as well as other media outlets such as Youtube.



#### Eligibility

Servicemen and servicewomen who participated in

wartime operations\* are eligible to participate in the project. In addition to military veterans, civilians who supported wartime operations or were significantly impacted by these operations are eligible (Examples: USO, DOD, Gold Star Mothers, 9/11 survivors, etc).

\* Wartime operations are defined as wars, expeditions and campaigns listed as eligibility for VFW membership.

#### **Interview Process**

- Veterans / eligible civilians should contact the WOHP requesting participation in the project. Contact: Greg Pass at <u>gpass@nmaw.org</u> or (571) 393-0756.
- 2. An interview date / time will be scheduled
- 3. A WOHP volunteer (interviewer) will contact the veteran to solicit more information about his/her service. This information is needed so the volunteer can prepare for the interview.
- 4. The veteran will be interviewed and the session videotaped. A typical interview lasts between 45 minutes to 90 minutes.
- 5. The veteran will receive a copy of the video. This may take up to a few weeks.
- 6. A copy of the video will be sent to the Library of Congress for retention.

#### How to prepare for your interview

Start thinking about your wartime experiences. Pull out your old photographs and documents to help jog your memory. Shoot a call to one of your war buddies and reminisce. Take a moment to think about what you would like your great-grandchildren to know about your service.

Some questions that your WOHP interviewer may ask during your interview:

- Do you have any other military veterans in your family tree?
- Do you remember where you were when you heard about the event that would lead to your wartime experience? (Pearl Harbor, 9/11, Invasion of Kuwait, etc)
- Why did you enter into military service?
- Where did you enter into training? What was your military occupational specialty?
- Where exactly did you serve?
- What were your duties?
- Did you see any combat?
- Were you or any of your buddies wounded?
- How did you stay in touch with your family while you were deployed?
- What did you do to keep busy while you were in theatre? (recreation, etc)
- Are there any incidents that stand out in your mind about your service in theatre? (Frightening, humorous or exciting experiences)
- Did you receive any medals, citations or awards?
- Can you describe your homecoming?
- How has your wartime experience affected your life?

#### What to bring to your interview



- 1. Signed copies of both WOHP and Library of Congress waivers as well as the Library of Congress Biographical Data Form (All three forms included in this packet)
- 2. Up to five (5) photos of you, preferably in uniform, while in theatre. Copies of your award citations or other documents are suitable as well. These photos and/or documents will be scanned and returned to you. (Or you can email these documents to your WOHP interviewer prior to the interview)

## FREQUENTLY ASKED QUESTIONS

#### What is the Wartime Oral History Project all about?

The project matches a staff of volunteers with Americans who have stories to tell regarding their service during times of war. Interviews are recorded on film and made available for researchers, family members and members of the public. Select interviews are edited into concise videos and available for viewing on the Museum website as well as Youtube.

#### I would like to be interviewed. Am I eligible?

Military veterans and other civilians who served during times of war are eligible.

#### Do I have to pay to be interviewed?

No.

#### What do I need to do to set up an interview?

Contact Greg Pass at gpass@nmaw.org A staff member will contact you to set everything up.

#### What do I need to bring with me to the interview?

Bring photos of interest (photo of you in uniform, photos taken of you in theatre, etc). Staff members will scan the photos (up to 5 photos) and return them to you.

#### How long will the interview take?

A typical interview lasts from forty five minutes to an hour and a half.

#### Can someone accompany me during my interview (dual interviews)?

In order to conduct a smooth interview only you will be present on camera during the actual filming of the video.

#### What should I wear to the interview?

Business or business casual attire is suggested, although not mandatory.

### Can I have a copy of the interview?

Yes. You will be provided a copy if requested. Please note it may take several weeks before you receive your video.

### I would like to volunteer to assist with the project. How do I become a part of the team?

We are in need of volunteers to assist with interviews, editing of raw film as well as the administration of the project. Volunteers are asked to provide 40 hours service a year. If you would like to help with this noble project contact Greg Pass at gpass@nmaw.org.
